### **Limitation of Liability**

Little-Masters Kids Event Company total liability for in contract, tort (including negligence or breach of statutory duty), misrepresentation, restitution or otherwise, arising in connection with the performance or contemplated performance of our agreement shall be limited to the price paid for the event.

The limitation on any exclusion from liability contained in these conditions shall be subject to the provisions of section 2(1) of the Unfair Contract Terms Act 1977.

Little-Masters Kids Event Company will not be liable in any amount for failure to perform any obligation our agreement if such failure is caused by the occurrence of any unseen event beyond its reasonable control including without limitation Internet and Communication outages, fire, flood, war or act of God.

## **Privacy Policy**

During the Little-Masters Kids Event Company booking process, we collect a minimum amount of data about you and your child(ren), which is stored on secure servers that support our website.

We collect:

- Your full name, address, telephone number and email address
- Your child(ren)'s name(s) and age
- Allergy information to help us risk assess our venue

This information:

- Is only available to authorised Little-Masters Kids Event Company staff
- Will never be shared with third parties
- Will only be used to make direct contact with you in matters relating to your booking.

## **WEBSITE COOKIES**

## HIRE AGREEMENT

### Booking & Cancellation

1. Full payment and acceptance of TERMS AND CONDITIONS is required prior to delivery.
2. On delivery of the hire items, you will be required to confirm receipt of delivery by phone message. You will be sent a video of the contents of your order.
3. In the event of your cancellation, the full amount minus the damage deposit is forfeited - it is non-refundable, IF more than 3 days' notice is given the full amount will be refunded.
4. Any changes to the booking must be received in writing and agreed by Little-Masters Kids Event Company prior to the hire date.
5. Any cancellations due to COVID-19, you will be asked to rebook at a future date: proof of positive test may be required.
6. Should you contract COVID-19 during your hire period, you must let us know as full PPE will be needed to collect the goods.
7. All prices are subject to change at any time (excluding confirmed bookings).
8. If Little-Masters Kids Event Company cancels the booking (excludes reasons beyond our control), full monies will be refunded.
9. The equipment needs to be laid on a hard standing, smooth, flooring
10. It is the responsibility of the Hirer to ensure easy access to the venue for unloading and loading of equipment. Any restrictions (e.g. lack of parking, stairs, and congestion zone) must be reported to Little-Masters Kids Event Company prior to the event. Failure to do so may result in an additional fee being payable by the Hirer.
10. The package includes free delivery to venues Enfield and Barnet. Venues beyond this may incur a delivery fee. Please contact us for details.
11. We will endeavour to arrive at the agreed time, but Little-Masters Kids Event Company will not be held responsible for delay incurred due to circumstances beyond our control (e.g. traffic problems, bad weather). Little-Masters Kids Event Company will communicate any delays at its earliest convenience.
12. A returnable deposit of damage fee for loss, damage or soiling of equipment will be returned at the end of the hire period once the equipment has been checked by Little-Masters Kids Event Company and all

is in order. If damage or loss has occurred the loss or damage deposit will be retained.

13. The Hirer will be responsible for any loss of equipment during the Hire Period and will be charged the full damage fee.

## **Health & Safety**

It is the responsibility of the person who is hiring the play package to ensure that all possible steps are taken to avoid injury or damage. Please ensure that the following Safety Instructions are followed:

1. The play equipment has a minimum age limit of 20 months and must be a confident walker. Please ensure no one under this age uses the Play equipment.
2. Any under 5 year olds at the party, the hirer must sign "Under 5s disclaimer waiver"
3. Please ensure that the play equipment is kept in a clean condition
4. No food or drinks or chewing gum to be allowed on or near the play equipment, this will avoid choking and mess (please note if the equipment is collected in a dirty condition then the person hiring it will incur the damage charge).
5. A responsible Adult (over 18 years old) must supervise the Play activity at all times.
6. Little-Masters Kids Event Company do not supervise the event.
7. Little-Masters Kids Event Company accepts no liability for any accidents or injuries that may occur whilst the equipment is on hire.
8. Always ensure that the party size is no more than 6 children.
9. Children must not push, collide, fight or behave in a manner likely to injure or cause distress to others.
10. Any long hair to be tied up.
11. DO NOT PLACE/ALLOW MOVING WHEELS TO GO NEAR HAIR. If entanglement does occur, switch train off, and attempt to detangle. This may cause pain and discomfort. You may need to cut hair to free from train. Little-Masters Kids Event Company does not accept liability for any loss of hair.
12. Keep equipment away from pets
13. Little-Masters Kids Event Company are covered by Public Liability Insurance, and a copy of this is available on request.
